Melquíades (Mel) Rafael Ruiz Martínez is a Cuban-American lobbyist and former politician who served as a United States senator from Florida from 2005 to 2009 and as general chairman of the Republican Party from November 2006 until October 19, 2007. Previously, Martínez served as the 12th Secretary of Housing and Urban Development under President George W. Bush. He resigned as general chairman of the Republican National Committee in 2007 and the Senate in 2009.

Martínez immigrated to the United States through Operation Pedro Pan, a Catholic initiative rescuing thousands of children. Graduating from Florida State University and its College of Law, he embarked on a 25-year legal career in Orlando, advocating for justice and serving his community. With a commitment to bipartisan approaches, he entered politics, becoming the Mayor of Orange County and later a Florida Senator, championing pragmatic governance.

His journey from immigrant to public servant is documented in his autobiography, *A Sense of Belonging: From Castro's Cuba to the U.S. Senate, One Man's Pursuit of the American Dream*. From leading the Orlando Housing Authority to serving as Secretary of HUD, he devoted himself to expanding homeownership and supporting communities, particularly minority and low-income families. Martínez recently retired as Chairman of the Southeast U.S. and Latin America for JPMorgan Chase & Co.
